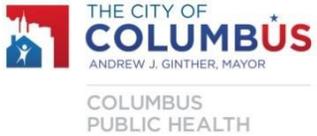


Franklin County Public Health CDC Overdose Data to Action Year One Grant Partners

September 2019 - August 2022

	<p>Franklin County Public Health</p> <p>As the lead agency for the Overdose Data to Action grant, Franklin County Public Health (FCPH) has the responsibility to enhance its opioid coalition building efforts by working across systems and organizations to expand data surveillance related to opioid use disorder and use the data to expand and improve a series of prevention efforts for populations at risk of overdose and unintentional overdose death. FCPH will also work collaboratively to develop a communications and marketing campaign to address the stigma surrounding opioid use disorders with input from at-risk populations via focus groups.</p>
	<p>Columbus Division of Fire</p> <p>The Columbus Division of Fire will enhance and expand Rapid Response Emergency Addiction Crisis Team (RREACT) efforts to link overdose survivors with treatment and recovery supports. This effort would promote direct engagement within communities and neighborhoods most impacted by opioid overdoses.</p>
	<p>Columbus Public Health</p> <p>Columbus Public Health will provide executive level epidemiologic input and data related to the innovation of an integrated data surveillance system. In addition, they will develop a web page that provides both local prescribers and patients with resources in the community that relate to prescribing protocols, treatment options, and educational resources and trainings, and serve as a repository for prevention, treatment and recovery resources.</p>
	<p>Educational Service Center of Central Ohio</p> <p>The Educational Service Center of Central Ohio (ESCCO) will expand Prime for Life, an evidence-based motivational prevention and pretreatment program specifically designed for people who might be making high-risk choices. This includes, but is not limited to, impaired drivers, college students and young people charged with alcohol and/or drug offenses. In addition, they will expand the Substance Abuse Family Education (SAFE) program and will also be a contributor of the data surveillance project.</p>
	<p>Equitas Health</p> <p>Equitas Health will expand harm reduction services beyond its doors into the community by hiring two community health workers to increase access to care and assess readiness for treatment and other needed resources related to linkages to care.</p>
	<p>Franklin County Children Services</p> <p>Franklin County Children Services will contribute to the innovative surveillance strategy by collecting, analyzing and sharing de-identified child welfare data gathered through its Statewide Automated Child Welfare Information System (SACWIS).</p>

 <p>Franklin County BOARD OF COMMISSIONERS 1803</p>	<p>Franklin County Office of Justice Policy and Programs</p> <p>The Franklin County Office of Justice Policy and Programs will expand its existing Peer Support Specialist (P2P) program to women in jails and expand the number of part-time peer support specialists on staff in order to offer linkage and support to justice involved males identified at booking into the jail with an opioid use disorder. They will also support street outreach and engagement staff and their efforts to reach individuals at greatest risk for overdose and death due to opioid abuse.</p>
	<p>Franklin County Coroner's Office</p> <p>The Franklin County Coroner's Office will assist in establishing a county-wide surveillance approach for first responder and social service risk factor data related to opioid use disorder through collaboration and epidemiologic support. In addition, they will provide administrative support for monthly reports, participate on surge notification calls, serve as a member of the county data team, and assist in the preparation of quarterly drug overdose death review meetings.</p>
 <p>Healthcare Collaborative of Greater Columbus</p>	<p>Healthcare Collaborative of Greater Columbus</p> <p>The Healthcare Collaborative of Greater Columbus will partner with FCPH and the City Attorney's office to engage in a pilot program for defendants who are summoned to appear in court on merchant theft cases. Individuals enrolled in the pilot program and determined to have low criminogenic risk and were not violent or aggressive in their behavior during their incident will be enrolled in the Pathways Community HUB model. If the person is eligible and agrees to participate, they will partner with a community health worker at a Care Coordination Agency for linkage to resources to address social determinant of health concerns.</p>
 <p>OACHC Ohio Association of Community Health Centers</p>	<p>Ohio Association of Community Health Centers</p> <p>The Ohio Association of Community Health Centers (OACHC) will increase the systematic use of the Ohio Automated RX Reporting System (OARRS) reports among all community health center (CHC) providers as a routine practice in patients with controlled substance use. OACHC will also assist in the education and training for CHC's on OARRS, linkages to care, and the health information exchange system.</p>
 <p>THE OHIO STATE UNIVERSITY COLLEGE OF PUBLIC HEALTH</p>	<p>The Ohio State University College of Public Health</p> <p>The Ohio State University College of Public Health will contribute to the surveillance system strategy by building capacity within low-resource EMS agencies for real-time data collection and developing an app that leverages FOCAL Map data for increasing linkage to care for those suffering an opioid overdose in community, healthcare and emergency department settings. This will ultimately increase linkage to care for those suffering an opioid overdose in the community.</p>

 <p style="text-align: center;">THE OHIO STATE UNIVERSITY WEXNER MEDICAL CENTER</p>	<p>The Ohio State University Wexner Medical Center</p> <p>The Ohio State University Wexner Medical Center will work with two local hospital systems and the OACHCs to develop a Peer Review Learning Lab to increase the systematic use of OARRS reports among the hospital and community health center providers (including pharmacists) as a routine practice in patients with controlled substance use.</p>
 <p style="text-align: center;">OHIO UNIVERSITY</p>	<p>Ohio University Voinovich School of Leadership and Public Affairs</p> <p>The Voinovich School of Leadership and Public Affairs will work in partnership with FCPH, its stakeholders, and partners to evaluate specific elements of the data surveillance project related to opioid use disorder, and use the data to improve a series of prevention interventions for populations at risk of overdose and unintentional overdose deaths.</p>
	<p>Capital Edge Consulting, Inc.</p> <p>Capital Edge Consulting, Inc. will develop a 2 CFR 200 compliant indirect cost allocation structure that can be utilized to recover indirect costs on federally sponsored programs.</p> <p>Communications Marketing Firm</p> <p>FCPH will contract with a communications marketing firm (TBD) to develop a comprehensive campaign to address the stigma surrounding opioid use disorder, overdose, disclosure, help seeking/treatment, and naloxone use.</p> <p>Local Hospital Systems (2)</p> <p>FCPH will contract with two local hospital systems (TBD) on strategies and activities related to prescription drug monitoring and health system support.</p>
